




- I, Melissa L. Halbig, being duly sworn, hereby depose and state as follows:



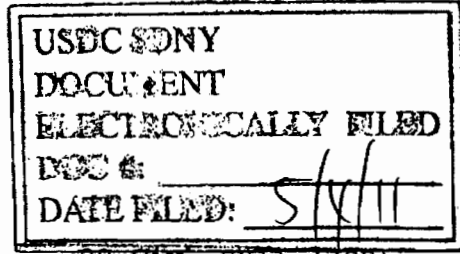

ORDER

JED S. RAKOFF, U.S.D.J.

Pending before the Court is the motion of Richard Schaeffer, Esq., to be relieved as counsel for defendant Steven Fortuna and to be replaced as counsel by Francis J. DiMento, Esq., and Michael S. Marino, Esq. In support of this motion, the parties have submitted: (1) an affidavit from defendant Steven Fortuna stating that he has elected to terminate Mr. Schaeffer's representation of him in this case and wishes to retain Mr. DiMento and Mr. Marino as counsel going forward; (2) affidavits from Mr. DiMento and Mr. Marino promising that they will abide by all previously set schedules in this matter; and (3) an affidavit from Mr. Schaeffer stating that he and his firm pledge to cooperate with Mr. Fortuna and his new counsel "with respect to the transition of the representation from my firm to them."

In light of the above representations, the Court hereby grants Mr. Schaeffer's motion to be relieved as counsel and approves the substitution of Messrs. DiMento and Marino as new counsel for defendant Steven Fortuna.
