

**NOTICE OF PLAINTIFF'S MOTION FOR PARTIAL SUMMARY JUDGMENT  
AGAINST DEFENDANTS RAJ RAJARATNAM  
AND GALLEON MANAGEMENT, LP**

PLEASE TAKE NOTICE that, upon the accompanying Declaration of John Henderson, dated October 7, 2011, Statement of Undisputed Material Facts Pursuant to Local Civil Rule 56.1, and Memorandum of Law, and all prior pleadings and proceedings had herein, Plaintiff Securities and Exchange Commission ("Commission"), by its attorneys, will move this Court, before the Honorable Jed S. Rakoff, at the United States District Court, Southern District of New York, United States Courthouse, 500 Pearl Street, New York, NY, 10007, at a hearing scheduled by the Court at 5:00 p.m. on October 28, 2011, for an Order, pursuant to Federal Rule of Civil Procedure 56, granting partial summary judgment against Defendants Raj Rajaratnam and Galleon Management, LP ("Defendants"), permanently enjoining Defendants from future violations of the federal securities laws, ordering Defendants jointly and severally liable for disgorgement

of \$31,563,661 and prejudgment interest of \$9,703,724.96, for a total of \$41,267,385.96, and imposing the maximum three-time civil penalty against Defendants pursuant to Section 21A of the Exchange Act, and for such other and further relief as this Court deems just and proper. By previous order of the Court, Defendants' Oppositions to this Motion are due October 17, 2011, and the Commission's Reply is due October 21, 2011.


