Re: Amazon's "Beware the SCAM Artists" Online Ad Campaign;
Unauthorized Use of ONEQUALITY.COM Mark; False
Advertising; Unfair Competition; Unfair Trade Practices

Dear Ms. Wilson:

This firm represents Sellify, LLC ("Sellify"), a Connecticut limited liability company. Sellify is the owner of the service mark ONEQUALITY.COM (the "Mark"), in connection with the online sale of (*inter alia*) used and overstocked electronic and digital consumer products via its OneQuality.com web site.¹ I am writing because Amazon's crude and unfounded online advertising campaign falsely tars my client and its people as "SCAM Artists" and "Scammers," and is unfairly and illegally crippling Sellify's ability to compete in the online marketplace.

The centerpiece of this ad campaign appears to be Amazon's purchase, and blatantly unfounded use, of the advertising keyword "onequality.com" from the Google web search service. Amazon has methodically and wrongfully worked to ensure that when a Google user punches in the search term "onequality.com," the search results page yields (a) a series of results that almost all direct the user to the onequality.com site and (b) a "sponsored ad" appearing either atop the search results or opposite the first result, and directing the user to the amazon.com web site. No other sponsored ad ever appears on the search results page.

¹ The Mark has been continuously used in commerce since at least March 7, 2007 by Sellify and its predecessor in interest, OneQuality LLC.

We may leave aside, for the moment, the question of whether Amazon has any legal right at all to purchase "onequality.com" as a keyword as part of a strategy to redirect potential customers from Sellify to Amazon, except to note that the most recent rulings of several U.S. Courts of Appeals on keyword purchase issues and the "initial interest confusion" test for trademark infringement surely cannot not give Amazon substantial comfort. In this instance, however, Amazon's actions go much further and are far less legally ambiguous. The Amazon keyword purchase results in the appearance of two or more different "sponsored ad" versions, each of which feature headlines incorporating some form of the term "scam."

Thus, for example, the search I performed earlier this week produced a "sponsored ad" bearing the headline "Beware the SCAM Artists" and subtitled "Camcorders at the Best Price From the Trusted Source," which is linked to the amazon.com site, which in turn is referenced at the bottom of the "sponsored ad" itself. In such fashion, the advertisement clearly implies that while Amazon is a "Trusted Source," the operator of the web site whose address is punched into Google by the user is a "SCAM Artist" that the user should "beware." It goes without saying that "onequality.com" is a very specific search term that could refer only to a unique web page (www.onequality.com), and it is now clear that each and every Google search for that term yields a "Scam" ad created and disseminated by Amazon. This carefully planned and planted association between onequality.com and "scam" is a prototypical example of false advertising and unfair competition, as variously defined in the federal Lanham Act and FTC Act, the Connecticut Unfair Trade Practices Act (CUTPA), and federal and state common law. CUTPA, for example, specifically prohibits a business from "[d]isparag[ing] the merchandise, services, or business of another by false or misleading representation of fact." Calling someone a "scammer" or "scam artist" is hardly a subjective judgment; it is a representation of fact, and in this case a damagingly false one.

Apparently, Amazon considers its goal of besmirching Sellify so important that it has purchased as keywords even misspelled variations on the mark. Thus, for example, when I punched the misspelled term "onequlaity.com" into the Google search engine, the first five results all referred to onequality.com or Sellify's OneQuality "store" on Ebay – but atop those results was another Amazon "sponsored ad" headlined, "Don't Buy from Scammers," also referencing the amazon.com site and directly linking to a page on that site featuring camcorders.

For your convenient reference, I have attached copies of the above-referenced Google search results. I note that the particular amazon.com page accessed by clicking on the "sponsored ads" that appeared as a result of the searches detailed above features specific camcorder items also sold by Sellify via its onequality.com site.

That a company of Amazon's size, power and reputation would engage in such a smear campaign against a much less well known competitor is shocking and appalling, and calls into question whether senior corporate management even knows what is going on within the company. Truly, the brazenness and ruthlessness of Amazon's ad campaign, as well as the precision with which the campaign is aimed directly at Sellify are striking. Clearly, the campaign is not directed at Google users who input generic terms such as "camcorders," "cameras" or "flat-screen televisions." It is specifically directed to users who input "onequality.com." Presumably, Amazon is well aware that users who use input the name of my client's web site on Google are not seeking to go to the onequality.com web page right away. (Such users could, obviously, choose to bypass Google and simply type "onequality.com" into their web browsers if that is what they wanted to do.) Rather, they are trying to find out information about onequality.com from sources other than the operator of onequality.com. They are most likely looking for third-party reviews of, and comments about, the services available through onequality.com. Amazon is apparently all too happy to provide such a "review" to each such user in the form of a jarringly blunt and false advertisement.


While there is absolutely no factual basis for Amazon to label Sellify as one of the "Scammers" or "SCAM Artists" it apparently feels so compelled to warn the public about, it should be readily apparent that this kind of labeling is overwhelmingly likely to be viewed by members of the consuming public as very credible. Amazon is one of the world's largest and most recognized consumer businesses. That Amazon is making the effort to identify onequality.com as a "scam" inherently carries considerable weight. Why, a consumer might ask, would Amazon, a huge and powerful company with such well-documented concern for its reputation for integrity, call out a much smaller online concern as a "scammer" unless the accusation were true? Surely Amazon does not fear onequality.com as a competitor; it only stands to reason that it is performing what it sees as a public service, by alerting the unwary consumer to the scam artist that lies in wait to steal the consumer's hard-earned dollars. Better to pay a higher price with Amazon, such an "informed" consumer would thus conclude, than to risk losing all with a company branded a "scammer."

In fact, there is very little that one could do to an online business that would be more damaging and injurious than what Amazon, with all of its power and prestige, has already done. Consequently, you are hereby placed on notice that this firm is preparing to commence an action against Amazon in an attempt to remedy the wrong that Amazon has perpetrated against Sellify, and seeking five million dollars (\$5,000,000.00) in damages and an immediate end to Amazon's scurrilous advertising campaign. We are willing to defer filing of the action if contacted by counsel for Amazon prior to the close of business on May 15, 2009, with a serious proposal for settlement that reflects the gravity (and potential application in other contexts) of Sellify's potential claims against Amazon.
