The Artist has no claim or right of any kind in or to any other artwork or material prepared by him and presently in Marvel's possession, except artwork or materials that has been contracted for under separate contract with Marvel (nor any claim or right on any artwork not prepared by the Artist), and Marvel may transfer such artwork or material to whomever it may desire, and utilize or exploit the same to the full extent provided herein with respect to the Artwork.
