MCI's foregoing assignment, grant, transfer and conveyance of its rights under copyright shall include, without limitation, all copyrights, all national, foreign, state and common law registrations, applications for registration and renewals and extensions thereof; and all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain all such registrations, renewals and/or extensions; to sue for all past, present or future infringements or other violations of any rights; and to settle and retain proceeds from any such actions).
