SUPPLEMENTAL SHORT FORM COPYRIGHT ASSIGNMENT

This Supplemental Short Form Copyright Assignment (this "Supplemental Assignment") is subject to all the terms and conditions of that certain Assignment Agreement (the "Original Assignment Agreement") between Marvel Characters, Inc. ("MCI") and MVL Rights LLC ("MRI") dated as of August 31, 2005 as amended by that certain Amendment No. 1 to the Transaction Documents (the "Amendment") dated as of the date hereof by and between MCI, MRI, HSBC Bank USA, National Association, in its capacity as Collateral Agent, Ambac Assurance Corporation, in its capacity as Control Party, MVL Productions LLC, Marvel Studios, Inc. and MVL Film Finance LLC and as further amended, restated or modified from time to time (such Original Assignment Agreement as amended by the Amendment and as further, amended, restated or modified from time to time, the "Assignment Agreement").

This Supplemental Assignment amends that certain Short Form Copyright Assignment dated as of August 31, 2005 by MCI to add additional Main Characters, Subsidiary Characters and Minor Characters (in each case, as defined in the Assignment Agreement) and Copyrights to the extent such Copyrights pertain to such added Characters. In the event of a conflict between this Supplemental Assignment and the Assignment Agreement, the terms of the Assignment Agreement shall control.

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, MCI hereby assigns, grants, transfers, conveys and delegates to MRI:

(i) all of MCI's right, title and interest of every kind and nature throughout the world in perpetuity in and to the Main Characters, Subsidiary Characters and Minor Characters (in each case, as defined in the Assignment Agreement) set forth on Schedule A attached hereto and incorporated herein by this reference; and

(ii) all of MCI's right, title and interest of every kind and nature throughout the world in perpetuity in and to all Copyrights (as defined in the Assignment Agreement), including without limitation, those copyrights set forth Schedule B attached hereto incorporated herein by this reference, but only to the extent such Copyrights pertain to the Main Characters, Subsidiary Characters or Minor Characters.

MCI's foregoing assignment, grant, transfer and conveyance of its rights under copyright shall include, without limitation, all copyrights, all national, foreign, state and common law registrations, applications for registration and renewals and extensions thereof; and all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain all such registrations, renewals and/or extensions; to sue for all past, present or future infringements or other violations of any rights; and to settle and retain proceeds from any such actions). MCI hereby reserves all right, title and interest of every kind and nature not expressly assigned to MRI in the Assignment Agreement, including without limitation, all right, title and interest of every kind and nature in and to all of the Non-Property Reserved Rights (as defined in the Assignment Agreement).
