A conference having been held with counsel for the respective parties today, it is hereby **ORDERED** as follows:

1. All fact discovery is to be completed by **THURSDAY, MARCH 31, 2011.**

2. The parties must make their initial expert witness disclosures described in Rule 26(a)(2) of the Federal Rules of Civil Procedure, if any, no later than **MONDAY, APRIL 25, 2011.** Rebuttal disclosures must be made no later than **WEDNESDAY, MAY 25, 2011.** Such disclosures must be made in writing, signed and served, but must not be filed with the Court.

3. All remaining expert witness discovery is to be completed by **FRIDAY, JUNE 24, 2011.**

4. Any potentially dispositive motions must be served and filed on or before **FRIDAY, JULY 29, 2011.**

5. The parties are directed to appear before The Honorable Laura Taylor Swain, United States District Judge, for a final pre-trial conference on **FRIDAY, SEPTEMBER 23, 2011, at 10:00 A.M.** This date shall replace the date set in paragraph 9 of Judge Swain's order of May 7, 2010, for purposes of all other deadlines set in that order by reference to that date.
