We represent Defendant Scholastic, Inc. in the above-identified matter. We write to respectfully request an amendment to the schedule. Counsel for Plaintiff has advised us that currently there is an initial pre-trial conference scheduled to take place on August 17, 2010 at 4:30 p.m. Unfortunately, I have a long-standing vacation scheduled for that week.
