PO Schoucraft's father called "City Hall" and
spoke to ~~the~~ Dep Mayor Slegler's assistant. The
father said that his son was never told why he is
on R/D. Sgt Bonilla reached out to PO
Schoucraft who said he was never told why he
is on R/D.

I told Sgt Bonilla that Dr. Lanstein was
away, so could not report in an exact conversation, but I
read some notes which confirm she "gave feedback," and more.
I told that our policy is to ~~make~~ make sure ~~mod~~ know why
~~the~~ they are being placed in R/D (even if they may
disagree). We also try to direct ~~mod~~ to places they
can get help, as Dr. Lanstein clearly did ~~it~~.

I told Sgt that Dr. Lanstein would call in
PO Schoucraft as soon as she returns, ^{and} answer any
questions he may have. Sgt Bonilla said that was
fine - it ~~was~~ could wait for Dr. Lanstein's return.

Ad explained to M05 that Ad called him in immediately upon my return from a 2 wk vacation b/c Ad received msg that his father made a complaint downtown that Ad never told M05 the reason why he is on R/P. Since we had discussed that in detail at his initial & subsequent visits, Ad emphatically expressed an uncertainty of how he may not have wanted to tell his father the reason why he was on R/P. To make sure that he has a clear understanding of why he is on R/P, Ad again explained in detail that he is on R/P b/c he had significant physical manifestations of stress that were causing med disruption & would benefit from treatment & further monitoring.

M05 sd he no longer has these physical stress even though he is still facing the same stress as before, while on R/P, he is at least clear of PET daily with complaints all day long - not stressful to him, but not very fun either (in his opinion) as regular F/P drinks.

Ad again re-emphasized stress mgmt & relaxation training so the next time he is faced with new increased stress, he won't have a recurrence of the chest pain, headache, morning upset stomach, etc, that he had for several months when he 1st came to PET. He said he bought both books Ad recommended & started reading them, but not that helpful since not much he didn't know before. He thought the Burns book was kind of boring & preferred the Ellis book. He ~~was~~ forgot both books to today's apt & had Bookman in there, ^{Ad} not very far into them (so hasn't read much of them). He said he called a few people Ad recommended but none took a extra & one wanted \$500/hour ^{Ad} - Ad told him Ad could help him find an Action Hospital & Ad is sure they must have CBT for physical stress. He said he would call later & his provider & if none of his present HMO plan so Ad can make sure the provider are in-network. M05 expressed an appreciation of the conversation.
