


Joseph J. Bial, being duly sworn, hereby deposes and says as follows:



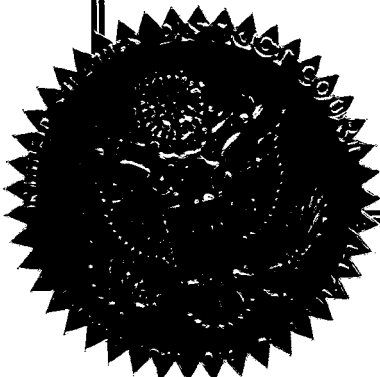


