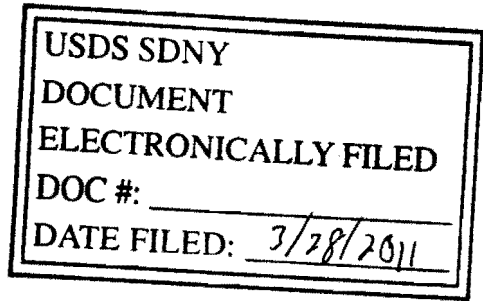



ORDERED that Assistant United States Attorney Sharon Cohen Levin and any individuals and entities who wish to oppose plaintiff's claim for forfeiture and assert an interest in the defendants-*in-rem* properties appear before the Honorable John G. Koeltl, United States District Judge, Southern District of New York, in Courtroom 12B of the United States Courthouse, 500 Pearl

Street, New York, New York, at 10:00 A.m. on the <sup>(15)</sup>21 day of April, 2011, to show cause why a default judgment should not be entered and the defendants-in-rem properties forfeited to the plaintiff United States of America according to law; and it is further


