Arastu K. Chaudhury, being duly sworn, hereby deposes and says as follows:



4. Jessica Valenzuela Santamaria is a partner at Cooley LLP in Palo Alto, California.

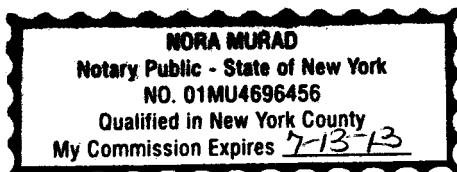




