Arastu K. Chaudhury, being duly sworn, hereby deposes and says as follows:



4. Elizabeth Stameshkin is an associate at Cooley LLP in Palo Alto, California.

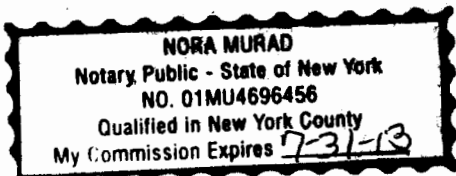
