



jurisdiction in which I am admitted to practice.



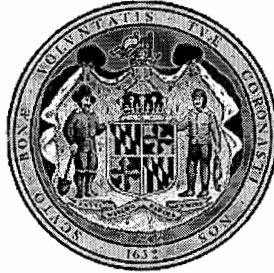
