The domain names shall be immediately transferred by their respective Registrars to an account of the Plaintiff, Commonwealth of Kentucky, at each Registrar or, if Plaintiff so specified, to such other Registrar as Plaintiff may designate. The domain names' configurations shall otherwise remain unchanged. The domain names shall not subsequently be transferred, moved, cancelled or otherwise affected except by instruction of the Plaintiff or this Court pursuant to KRS 528.100 and/or KRS 500.090.
