PLEASE TAKE NOTICE that BLANCA GAMES, INC., on behalf of itself and the following entities: Absolute Poker, SGS Systems Inc., Trust Services Ltd., Fiducia Exchange Ltd., Blue Water Services Ltd., and Absolute Entertainment, S.A. (collectively "Claimant"), pursuant to 18 U.S.C. § 983(a)(4) and Rule G(5)(a), Supplemental Rules for Admiralty or Maritime Claims and Asset Forfeiture Actions, by and through its attorneys, hereby asserts ownership in, and makes claim upon, all right, title and interest in the assets of Claimant that have been restrained, seized or referenced in the Verified First Amended Complaint ("Amended Complaint") in the above-captioned case, including, but not limited to, the following:

1. Absolutepoker.com, Ultimatebet.com, and Ub.com (the “Domain Names”) and
2. The Blue Water account and the Tokwiro account as described in paragraphs 16 and 17 of Schedule A in the Amended Complaint (the “Blanca Games Accounts”).

Pursuant to Rule E(8) of the Supplemental Rules for Admiralty or Maritime Claims, Claimant’s appearance is expressly restricted to the defense of this claim, and the Verified Claim does not constitute an appearance for any other purpose, nor does it confer jurisdiction over Claimant.

Claimant asserts right, title and interest in the Domain Names and Blanca Games Accounts based on legal and equitable ownership, which was acquired by the lawful establishment of the Domain Names and accounts.

Claimant reserves the right to amend or supplement this claim after learning of new information, including information related to additional assets that are subject to forfeiture.




