



National September 11 Memorial & Museum at the World Trade Center Foundation, Inc. has no parent corporation and no stock, meaning that there is no “publicly held corporation owning 10% or more of its stock” within the meaning of Federal Rule of Civil Procedure 7.1(a)(1).

2. Lower Manhattan Development Corporation is a subsidiary of the New York State Urban Development Corporation, doing business as Empire State Development. New York State Urban Development Corporation is a public benefit corporation of the State of New York.
