**DECLARATION OF  
RICHARD S. MANDEL, ESQ.**

RICHARD S. MANDEL, pursuant to 28 U.S.C. § 1746, declares as follows:

1. I am a shareholder in the firm of Cowan, Liebowitz & Latman, P.C., which represents Plaintiffs in this action. I submit this declaration in support of Plaintiffs’ Memorandum of Law Regarding the Application of Res Judicata to the Individual Defendants’ Affirmative Defenses. I have personal knowledge of the facts set forth herein.

2. Attached hereto as Exhibit A is a true and correct copy of ReDigi’s initial disclosures in this action. Mr. Ossenmacher and Mr. Rudolph were the only witnesses identified by ReDigi.
