In light of the Court's finding that Defendants did not demonstrate – in opposing the motion to amend – that Plaintiff had engaged in inequitable conduct (Dkt. No. 147),

Defendants are directed to state whether they agree to the dismissal of their Twelfth Affirmative

Defense and Counterclaim V. (See Dkt. Nos. 141-42) Defendants' statement should be included in the parties' joint letter.
