## JOHN F. KEENAN, United States District Judge:

The Court hereby holds that it is divested of the jurisdiction to decide Plaintiff's pending motion for leave to amend (ECF No. 30) as (1) resolving that motion would control aspects of the case involved in the appeal (see Kilpatrick v. Henkin, 17-CV-5111 (CM), 2018 WL 1684410, at \*1 (S.D.N.Y. Jan. 5, 2018) (citing Griggs v.
