The Court having been advised (Docket No. 75) that all claims asserted herein have been settled in principle, it is ORDERED that the above-entitled action be and is hereby dismissed and discontinued without costs, and without prejudice to the right to reopen the action within thirty days of the date of this Order if the settlement is not consummated.

Any pending motions are moot. All conferences are vacated. The Clerk of Court is directed to close the case.
