Pursuant to the telephonic conference held today, February 5, 2024, the Court orders as follows:

- Defendant's motion for an Order compelling non-parties Yudelka Carrero and Lighter Aracena to appear for depositions (ECF No. 40 at 1–2) is HELD IN ABEYANCE pending the parties' efforts to have the non-parties appear voluntarily for deposition.
- Defendant's request (ECF No. 40 at 2–3) that the Court so-order document subpoenas for certain of Plaintiff's cell phone records to Verizon (ECF No. 40-5) and T-Mobile (EF No. 40-6) is GRANTED. The Court will enter the subpoenas by separate Orders.
- 3. The parties' joint request for an extension of time to complete fact and expert discovery (ECF No. 41) is GRANTED.
  - a. The fact discovery deadline is EXTENDED from February 12, 2024 to
     March 28, 2024. By April 4, 2024, the parties shall file a joint letter certifying the close of fact discovery.

b. The expert discovery deadline is EXTENDED from May 10, 2024 to June 24,
 2024. By July 1, 2024, the parties shall file a joint letter certifying the close of all discovery.

4. A telephonic status conference is scheduled for Tuesday, March 12, 2024 at 12:00 p.m. on the Court's conference line. The parties are directed to call: (866) 390-1828; access code: 380-9799, at the scheduled time.
