

a PDF reader and a PDF writer to convert word-processing documents into PDF format, the only electronic format in which documents can be e-filed


version of PDF reader and writer that I will be using:

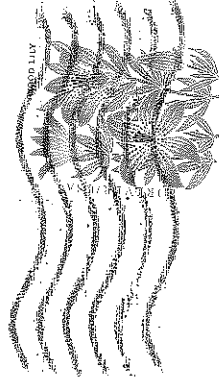
