I, AMANDA M. AYCOCK, hereby declare under penalty of perjury that the following is true and correct:

1. I am an attorney licensed to practice law in the State of New York. I am an associate attorney at the law firm of Gibson, Dunn & Crutcher LLP ("Gibson Dunn"), counsel of record for Mark Elliot Zuckerberg and Facebook, Inc. ("Facebook") in the above-captioned matter. I make this declaration, based on personal knowledge, in support of Defendants' Reply in Support of Defendants' Accelerated Motion to Compel Compliance with Paragraph 5 of the August 18 Order.

2. On August 29, 2011, Plaintiff's counsel Nathan Shaman represented that because Plaintiff Paul Ceglia "does not have a scanner, he is not able to provide us with original signatures at this time." See Exhibit A.

3. On September 26, 2011, Mr. Shaman attested that Plaintiff has "sent out" the consent forms required by this Court's August 18th Order, presumably by first-class mail. See Shaman Decl. at ¶ 2.

4. I understand, based on public news reports, that Plaintiff Paul Ceglia currently resides in or near Galway, Ireland. See, e.g., Dara Bradley, *Facebook battle man living in*

Galway for past two months, THE CONNACHT SENTINEL, August 16, 2011, available at <http://www.galwaynews.ie/21013-facebook-battle-man-living-galway-past-two-months>.

5. I conducted an Internet search for businesses providing scanning services—which would allow a person to scan hard-copy documents and then immediately email them as electronic documents—in Galway, Ireland. This search identified at least two businesses in the area that provide such services:

6. I also conducted an Internet search for businesses providing expedited international shipping services in Galway, Ireland. This search identified at least two businesses in the area that provide such services:



7. It is my understanding that this Federal Express location in Shannon is approximately one hour from Galway by car. On September 27, 2011 at approximately 2:30 p.m., I confirmed via telephone with a Federal Express representative that this location offers pick-up for express shipping.

8. Thus, there are numerous businesses that offer scanning or express shipping services near Plaintiff's current residence that would allow him to transmit the executed consent forms immediately.
