WRITTEN PLEA IN ABSENTIA

Defendant, **PAUL CEGLIA**, pursuant to Rule 3.180(c), Florida Rules of Criminal Procedure, requests that the court allow the defendant to enter this written plea of NO CONTEST in absentia to the charge of Trespass on Property Other Than a Structure or Conveyance. This plea is entered with the understanding that the defendant will receive the following sentence:

1. Fine and court costs in the amount of 262.50; and
2. If the Court grants a WITHHOLD OF ADJUDICATION, a withhold of adjudication.


It is understood that a withhold of adjudication is within the discretion of the court, the State, ASA, Amanda Bolin, has no objection to a withhold of adjudication and defendant respectfully requests a withhold of adjudication based on the lack of criminal history and the nature of the offense.

Defendant certifies that he has discussed his case with his attorney, Paul J. Blenk, and that he enters his plea freely and voluntarily, knowing that by entry of this plea, that if not a U.S. Citizen, I could be deported and the following constitutional rights are waived:

- a. The privilege against compulsory self-incrimination which includes the right to plead not guilty;
- b. The right to a trial in which the State must prove guilt beyond a reasonable doubt;

- c. The right to a speedy trial and public trial by an impartial jury;
- d. The right to confront and cross-examine witnesses against him;
- e. The right to compulsory process to obtain witnesses in my favor;
- f. The right to have the effective assistance of counsel for defense at trial;
- g. The right to appeal;
- h. The right to present any defense in his behalf.


