ORDER

THIS MATTER came to be heard on the motion of Plaintiffs Carolina Power and Light Company d/b/a/ Progress Energy Carolinas, Inc. (“Progress”) and Consolidation Coal Company (“Consol”) and cross-claim, counterclaim, and third-party Plaintiff PCS Phosphate Company, Inc. (“PCS”) (collectively “Plaintiffs”) for an Order under Fed. R. Civ. P. 41(a)(2) to dismiss Kobe Copper Products. Inc. (“KCPI”) from the above-captioned actions.
