DEFAULT JUDGMENT

This matter is before the Court on Plaintiff's Motion for Default Judgment. - 2. All persons claiming any right, title, or interest in or to the said defendant are held in default;
- 3. The defendant is forfeited to the United States of America;
- 4. This Court entered Default in this action at Docket Entry # 10;
- 5. The U. S. Marshal's Service is hereby directed to dispose of the defendant according to law; and
- 6. Upon the entry of this judgment, the Clerk of Court is DIRECTED to close this case.
