This matter is before the Court on plaintiff's second motion made pursuant to Rule 60 of the Federal Rules of Civil Procedure. The Court previously denied plaintiff's first motion pursuant to Rule 60 in December 2014 because plaintiff offered no extraordinary circumstances that justified relief nor did he articulate any manifest injustice that would result from the dismissal of his complaint as frivolous.
