THESE MATTERS are before the Court on the separate Confession

of Judgment documents [Docs. 92 and 93] executed by Defendant Michael

Andrew Alexander in favor of each of the minor Plaintiffs.¹ Based upon these filings, the Court finds that the Defendant Michael Andrew Alexander has: (1) authorized the Court to enter judgment against him and in favor of minor Plaintiff M.G. in the amount of One Million Dollars (\$1,000,000.00) [Doc. 92]; and, (2) authorized the Court to enter judgment against him and in favor of minor Plaintiff A.L. in the amount of One Million Dollars (\$1,000,000.00) [Doc. 93].

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that:

(1) Judgment is hereby entered in favor of minor Plaintiff M.G. and against the Defendant Michael Andrew Alexander on all claims asserted by said Plaintiff against said Defendant and minor Plaintiff M.G. shall have and recover One Million Dollars (\$1,000,000.00) from the Defendant Michael Andrew Alexander in the form of damages; and

(2) Judgment is hereby entered in favor of minor Plaintiff A.L. and against the Defendant Michael Andrew Alexander on all claims asserted by said Plaintiff against said Defendant and minor Plaintiff A.L. shall have and recover One Million Dollars (\$1,000,000.00) from the Defendant Michael

Andrew Alexander in the form of damages; and

(3) The parties shall bear their own costs of this action.
