
MOTION TO ADD ADDITIONAL EVIDENCE

Plaintiff, Lynn Ellen Mendes, would like to add additional urgent evidence as the plot toward her and threatens to engulf her family thickens. Unless circumstances change, her daughter, Melina Laurin has already submitted her resignation to leave her employment at Flakeboard in Ft. Mill, SC. She said this was due to a heavy workload she felt was unreasonable. They refused to hire a second person to ease the work load. Ms. Mendes expresses some concern as her daughter, Melina, was the one that accompanied her to her MRI appt. at Metrolina Diagnostic Center in Rock Hill, SC on February 12<sup>th</sup>, 2011. Ms. Mendes is still attempting to get further testing done on damage to her brain which effectively began on October 30<sup>th</sup>, 2000. Ms. Mendes has already expressed concern that an expulsion from the library already can be seen as an action to Melina and Sean's young son, Brady Laurin as Ms. Mendes brings her grand son reading material.

Also attached is a ticket Ms. Mendes received on the Lynx, May 5<sup>th</sup>, 2011, when she failed to purchase a day ticket as Ms. Mendes usually purchases a monthly pass as she is currently on disability. Ms. Mendes does not feel liable for the ticket as the same circumstances Ms. Mendes complains about (constant stalking and harrassment by unknown female assailants with spy equipment via penetration of the brain). The Charlotte Area Transportation System has also been known to participate and complaints have been lodged with them as well to not allow this activity as it is criminal, illegal, unconstitutional, not to mention cruel and inhumane. This activity must be discovered and eradicated altogether. In regards to the ticket Ms. Mendes will also argue there is no collection system aboard the Lynx and no reminders issued over their intercom system. The FAA, Amtrak, and Greyhound have also participated since Ms. Mendes's ordeal began. Ms. Mendes has filed complaints with the NTSB but not Greyhound. Only a minor attempt at notifying Amtrak was made. This makes travel for Ms. Mendes extremely difficult with no assurance she will make it to her destination.

Complaints of cyberstalking have now been lodged with the FBI and police departments from Anchorage, Wasilla, and now the Sacramento Police Departments as notes being placed on the

Facebook pages of Sarah Palin and now Jerry Brown are reverting back to Ms. Mendes's Facebook thread. This is not where Ms. Mendes wants them as it only serves to upset Ms. Mendes's family as she made promises to keep any politically oriented comments off the Facebook thread. This could prove embarrassing to their friends and/or family and is not helpful in the least.
