**MOTION TO ADD ADDITIONAL URGENT EVIDENCE
AND REQUEST FOR GRAND JURY INVESTIGATION**

Plaintiff, Lynn E. Mendes, continues to petition the Court as having proper jurisdiction over a matter involving violation of her civil rights for the last 6 ½ years through penetration of her brain involving use of equipment now known to the courts as evidenced in earlier exhibits.

John Fleming, "The shocking menace of satellite surveillance". Also know to author Ronald Kessler, author of "Inside the CIA revealing the secrets". The female operatives, believed to be lesbians have taken Ms. Mendes hostage now as indicated for over 6 ½ years beginning in Pawtucket, R.I. and continuing on to her current location, Charlotte, N.C. Here in Charlotte, NC now going on 2 years with an effective date of July 16, 2009. Ms. Mendes never gave her permission, is not nor ever was a lesbian and it's purpose was to extort money from Ms. Mendes or for embezzlement from another source. The female operatives use the equipment on a 24/7 basis traveling everywhere Ms. Mendes goes amounting to a GPS tracker of a human; i.e. for stalking and harrassment purposes. Such cities as New York City, Seattle, WA, Washington D.C., Providence, R.I., New Bern, NC, Raleigh, NC. They are not welcome to pursue Ms. Mendes and insist the courts issue a cease and desist order and prosecution of the responsible parties which would also include the Charlotte Mecklenberg Public Library. They also watch Ms. Mendes as she sleeps, showers, toilet, know personal information such as bank account info, etc. It is used as an eveasdropping device for the purpose of watching Ms. Mendes, seeing and hearing her, tuning into her "thoughts" which are not supposed to have anything to do with females. This was their desire; thus wishing to make alterations to images Ms. Mendes's portrays in her brain. Ms. Mendes is not their prisoner, human experiment, human subject, spouse, lover, friend, property, dog, etc. The 13th Amendment of the United States Prohibits slavery and Ms. Mendes refuses to be a party to such equipment which is a

total violation of an individual's human rights. She also does not believe in lesbianism. The answer is no irregardless of how the courts rule and will be anyone's answer when the truth be known should an attack occur on their own person.

Please find attached the computer disk of an MRI taken by Dr. Howard Mandell, on February 12th, 2011 and while Ms. Mendes is under the belief more damage should be appearing with her brain damage dating back 10 ½ years. Ms. Mendes continues to request Dr. Mandell continue additional testing, often concerned she is on the verge of a stroke. The same condition which necessitated a visit to the emergency room at Carolina Medical Center after being rear-ended from behind on 12/15/2008 by an individual of Chinese descent who failed to provide his name, number, and address. Information Ms. Mendes sought. The Charlotte Mecklenberg Police Department refuses to write it up as a hit and run although Ms. Mendes is under the belief a CMPD officer had been made aware of the alleged accident in which she almost asphyxiated. An officer on a motorcycle who is believed to have made a later appearance at the Rite-Aid on Park Rd. after Ms. Mendes had taken some extremely private photos attempting to bait the women. It is not known if these hard core female sexual predators viewed these photos without Ms. Mendes's permission and have them "tacked to their wall".

Also being entered evidence is a letter written to the Central Intelligence Agency requesting service records of Joseph Patrick Kennedy Jr., her deceased uncle, Payton H. Courtney, and her deceased father, Roberto G. Sanchez, a native of Tampico, MX.
