P. 60(b)(6). In addition, unless a party formally advises the Court within thirty (30) days that it does not consent to the terms of this Order, the parties to it are hereby deemed to consent to this Court retaining jurisdiction to enforce the settlement agreement. Kokkonen v. Guardian Life Ins. Co., 511 U.S. 375, 381-82 (1994). The dismissal hereunder shall be with prejudice if no action is taken under either alternative within sixty (60) days from the filing date of this Order.
