THIS MATTER IS BEFORE THE COURT on "Liberty Mutual Fire Insurance Company And Liberty Mutual Insurance Company's Motion To Intervene" (Document No. 8) filed November 6, 2014. This motion has been referred to the undersigned Magistrate Judge pursuant to 28 U.S.C. § 636(b), and is ripe for disposition. Having carefully considered the motion, the record, and applicable authority, the undersigned will <u>grant</u> the motion.

Liberty Mutual Fire Insurance Company And Liberty Mutual Insurance Company ("Liberty Mutual Defendants") persuasively assert that: (1) their interests in this action are sufficient to merit intervention; (2) their interests may be impaired absent intervention; and (3) the existing parties do not adequately represent their interests. (Document Nos. 8 and 9). Moreover, Plaintiff has indicated that he does not object to the instant motion, and Defendant has declined to file any response. See (Document No. 8, p.5); Local Rule 7.1 (E).

IT IS, THEREFORE, ORDERED that "Liberty Mutual Fire Insurance Company And Liberty Mutual Insurance Company's Motion To Intervene" (Document No. 8) is **GRANTED**. Intervenor Defendants shall have up to and including **December 8, 2014** to file an answer or otherwise respond to Plaintiff's Complaint.¹
