ORDER


THIS MATTER IS BEFORE THE COURT on “Michael Foster’s [Motion and] Memorandum Of Law In Support Of His Motion To Intervene Pursuant To Rule 24(a)(2) And (b)(1)” (Document No. 41) filed January 20, 2017. This motion has been referred to the undersigned Magistrate Judge pursuant to 28 U.S.C. § 636(b), and is ripe for disposition.
