Pilkington's reply brief on its motion and opposition to the defendants' cross-motion; Aeroquip-Vickers' and Eaton's brief responding to defendants' cross-motion	August 15, 2004
Fact witness discovery completed	August 16, 2004
Defendants' reply brief on their cross-motion	August 31, 2004
Exchange of expert witness reports. Reports to be served by the party having the burden of proof on the issue which is the subject of the report. In all other respects <u>Federal Rule of Civil Procedure 26(a)(2)</u> shall govern	August 31, 2004

Opposition expert reports to be submitted pursuant to the format specified in <u>Federal Rule of Civil Procedure 26(a)(2)</u> by parties not having the burden of proof on a particular issue	October 1, 2004
Last day to complete expert witness depositions; all parties to make expert witnesses designated by their counsel available for deposition on reasonable notice without the need for service of a subpoena	November 15, 2004
Last possible date to file motions for summary judgment or partial summary judgment, but same may be filed at any earlier time	December 15, 2004
Last possible date for opposition to motions for summary judgment or partial summary judgment and/or cross-motions to be filed	January 19, 2005
Last possible date for reply on motions for summary judgment or partial summary judgment (and opposition to cross- motions) to be filed	February 9, 2005
Last possible date for reply on cross-motions for summary judgment or partial summary judgment	February 28, 2005
Plaintiff's good faith settlement demand on defendants	April 20, 2005
Defendants' good faith settlement offer to Plaintiffs	April 27, 2005
Parties to submit ex parte narrative settlement statements to court	April 27, 2005
Final settlement conference	May 2, 2005 at 1:30 p.m.
Motions in limine to be filed	May 13, 2005
Opposition to Motion in limine to be filed	May 20, 2005
Submit jury instructions	May 29, 2005
Mark and exchange exhibits and exchange witness lists	May 29, 2005
