The within matter is before the Court pursuant to Local Rule 37.1 upon the following:

- 1.) a letter dated June 6, 2008, from Patricia Ambrose Rubright, one of the attorneys for defendant City of Akron;
- 2.) a letter dated June 12, 2008, from Attorney Rubright;
- 3.) the curriculum vitae of Paul Richard Jeanneret, Ph.D;¹
- 4.) Plaintiffs' Status Report (Doc. 67);
- 5.) a second letter, dated June 12, 2008, from Attorney Rubright;
- 6.) a letter dated June 12, 2008, from Dennis R. Thompson, one of the attorneys for plaintiffs; and
- 7.) a letter, dated June 13, 2008, from Attorney Rubright.

Fed. R.Civ. P. 26(b)(4)(C)(i) provides in part that the court shall require that the party seeking discovery "pay the expert a reasonable fee for time spent in responding to discovery."

In balancing the relevant factors set forth in *Goldwater v. Postmaster General of U.S.*,

136 F.R.D. 337, 340 (D.Conn. 1991) (six-factor test) and *Jochims v. Isuzu Motors Ltd.*,
141 F.R.D. 493, 495-96 (S.D.Iowa 1992) (seven-factor test), the Court fixes Dr. Jeanneret's fee
at \$500 per hour for the giving of a discovery deposition, plus \$500 per hour for preparation
time. The Court finds that this amount is reasonable and will fairly compensate Dr. Jeanneret for
his time in participating in this litigation.
