

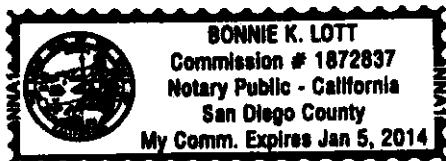
6. As noted, I am a member in good standing of the bar to which I have been admitted and have had no disciplinary or grievance proceedings filed against me.


