CALENDAR ORDER

Pursuant to the filing of the Rule 26(f) Report by the parties, this case shall proceed as follows:

1. Deadline to file motion for leave to amend the complaint: **November 3, 2008**
2. Deadline for motions relative to the pleadings: **December 1, 2008**
3. Deadline for disclosure of expert witnesses and submission of expert reports¹:
Plaintiff disclosure and report of experts: **October 15, 2008**
Defendant disclosure and report of experts: **January 15, 2009**
Disclosure and report of rebuttal experts: **February 27, 2009**
Disclosure of non-expert (fact) witnesses: **October 1, 2008**
4. Discovery deadline²: **March 31, 2009**
5. Telephone Status Conference³: **April 7, 2009 at 2:00 pm**
6. Dispositive motion deadline⁴: **May 1, 2009**
7. Settlement Conference⁵: **June 3, 2009 at 1:30 pm**

¹Disclosure of Experts and Expert reports are not required to be filed with the Court.

²Counsel shall not presume that a pending motion stays their obligation to complete discovery by this date.

³Parties shall initiate contact with the Court by calling 513-564-7660 five minutes prior to the scheduled time.

⁴Counsel shall familiarize themselves with the Court's Standing Orders and S.D. Ohio Civ. R. The Court will not read beyond 20 pages unless leave has been previously sought and granted. This Court requires courtesy copies of all substantive motions be delivered to chambers upon filing.

⁵Special Instructions regarding settlement: 1. All parties must bring their client or a representative with full settlement authority. Failure to follow this requirement will result in sanctions; 2. Each counsel must prepare and submit via hand delivery to the Court or via the chamber's email address at: barrett_chambers@ohsd.uscourts.gov a letter no longer than five pages one week prior to the conference a synopsis of the case and the status of any settlement negotiations to date. These letters **NEED NOT** be filed with the Clerk's Office nor exchanged with opposing counsel.

8. Joint Final Pretrial Order/Jury Instructions⁶: **October 1, 2009**
9. Final pretrial conference: **October 8, 2009 at 1:30 pm**
10. Trial: **November 9, 2009 at 9:30 am, Courtroom 3, Room 836**
