1. Defendants will file a Supplemental Brief in Support of Motion for Attorneys’ Fees (“Supplemental Brief”) on or before November 23, 2009;

2. Plaintiffs will file a combined response to the Rule 11 Motion and the Supplemental Brief within thirty days after Defendants file the Supplemental Brief (the “Combined Opposition”);

3. Defendants will file a combined reply brief in support of their Rule 11 Motion and
