DECISION REGARDING DESIGNATIONS IN THE DEPOSITION OF PAUL GEMBARA

This case is before the Court on the parties' request that the Court rule in limine on the admission of designated and cross-designated portions of depositions to be played at trial from edited videorecordings of the depositions.
