This matter came before the Court upon the oral motion of defense counsel for an extension of the preliminary injunction hearing and discovery schedule in this matter.

3. The parties are permitted to issue subpoenas for documents and depositions to non-party witnesses, including but not limited to Brian Klaus, an employee of Johnstone Supply, Inc. Johnstone Supply will make Klaus available for deposition.

4. The hearing on plaintiff motion for preliminary injunction is re-set from April 27, 2010 at 8:30 a.m. to May 6, 2010 at 9:00 a.m.
