CORRECTED OPINION AND ORDER DENYING CERTIFICATE OF APPEALABILITY

On June 14, 2013, the court dismissed petitioner's petition for a writ of habeas corpus as barred by the statute of limitations (Docket No. 16). After a careful review of the record, the court concludes petitioner has not shown "at least, that jurists of reason would find it debatable whether the petition states a valid claim of the denial of a constitutional right and that jurists of reason would find it debatable whether [this] court was correct in its procedural ruling." *Slack v.
