 16 Upon consideration of Plaintiff’s Motion Re: Attorney Fees and Costs Pursuant to the
 17 EAJA (Equal Access to Justice Act, 28 U.S.C. 2412(d)),

18 It is hereby ORDERED that the Motion is granted. Defendant shall pay \$2,496.72 in
 19 attorney’s fees and \$96.60 in expenses under 28 U.S.C. § 2412, and \$400.00 in costs under 28
 20 U.S.C. § 1920.

 22 Pursuant to *Astrue v. Ratliff*, 130 S.Ct 2521, 2528-29 (2010), EAJA fees awarded by this
 23 Court belong to Plaintiff and are subject to offset under the Treasury Offset Program (31 U.S.C.
 24 § 3716(c)(3)(B) (2006)). If after receiving the Court’s EAJA fee order, the Commissioner
 25 determines upon effectuation of the Court’s EAJA fee order that Plaintiff does not owe a debt
