1 - ORDER

HERNANDEZ, District Judge:

Magistrate Judge Jelderks issued a Findings and Recommendation (#45) on March 5, 2013, in which he recommends that the Court deny the amended petition for writ of habeas corpus (#14) and dismiss this case with prejudice. The matter is now before me pursuant to 28 U.S.C. § 636(b)(1) and Federal Rule of Civil Procedure 72(b).

Because no objections to the Magistrate Judge's Findings and Recommendation were timely filed, I am relieved of my obligation to review the record *de novo*. <u>United States v.</u>

Reyna-Tapia, 328 F.3d 1114, 1121 (9th Cir. 2003) (en banc); see also <u>United States v. Bernhardt</u>, 840 F.2d 1441, 1444 (9th Cir. 1988) (*de novo* review required only for portions of Magistrate Judge's report to which objections have been made). Having reviewed the legal principles *de novo*, I find no error.

## **CONCLUSION**

The Court adopts Magistrate Judge Jelderks' Findings and Recommendation (#45).

Therefore, the amended petition for writ of habeas corpus (#14) is denied and this case is dismissed with prejudice. A certificate of appealability is also denied because petitioner has not made a substantial showing of the denial of a constitutional right.
