I am in receipt of Paul Lantieri's Second Request for an Extension of Time to Respond to our Motion for Class Certification. Clearly, it is the School District's intention to objection to the Class Certification, otherwise additional time would not be needed.

The Defendants have had plenty of time to mount whatever arguments they may have against including all Lower Merion School families in this case so that they may be included in the equitable relief Plaintiffs have been working to achieve. Plaintiffs do not believe it's prudent to allow any further delays, especially a delay on the eve of the date that the response is due. The Plaintiffs would respectfully request that the Court require the Defendants to respond to the Class Certification Motion as scheduled, on July 7, 2010, so that this important matter can be promptly heard.

As Your Honor is aware, until the Class is certified, Plaintiffs cannot move forward to settle the equitable Class and make permanent the injunction relief already obtained. If the Court is not going to grant the Motion for Class Certification, the


