**SUPPLEMENTAL DECLARATION OF JOHN ROUNTREE IN SUPPORT OF  
DEFENDANTS LINDEN RESEARCH, INC. AND PHILIP ROSEDALE'S  
MOTION TO DISMISS UNDER RULE 12(B)(6)  
OR IN THE ALTERNATIVE TRANSFER PURSUANT TO 28 U.S.C. § 1404(a)**

**Supplemental Declaration of John Rountree**

I, John Rountree, declare as follows:

1. I am Director of Customer Relations of defendant Linden Research, Inc. (“Linden Lab”), a Delaware corporation headquartered in San Francisco, California. As part of my responsibilities, I manage the teams that respond to customer inquiries and complaints. I have personal knowledge of the facts set forth in this declaration and, if called as a witness, could and would testify competently to them.

2. I submit this supplemental declaration in response to the Court’s request for supplemental briefing.

3. My original declaration included a chart (Exhibit G) listing the creation dates, subsequent Terms of Service agreement dates, and last login dates for 101 separate Second Life accounts identified as belonging to Carl Evans. The entry for Evans Account Number 99 reading “CURRENTLY ACTIVE” indicated that the account was currently in use as of the day the chart was compiled. I have been asked to update that data, and have confirmed that that account has been in nearly daily use, and was accessed at least as recently as September 29, 2010. In addition, three more accounts have been identified as belonging to Mr. Evans, each of which is also active on a near-daily basis. This updated data is set forth in Exhibit A hereto, and the three additional accounts of Mr. Evans are identified as Evans Account Numbers 102, 103, and 104.

4. I have been asked to provide the same categories of data for the Second Life accounts identified as belonging to Cindy Carter, Donald Spencer, and Valerie Spencer. That data is also set forth in Exhibit A.


5. Exhibit G to my prior declaration includes three different dates (where available) for each account. First, there is the date on which the account was created. In the process of creating an account, the user must click on a “Create Account” button with the legend “By

clicking Create Account you are indicating that you have read and agree to the **Terms of Service Agreement** and **Privacy Policy**.” A true and correct copy of that page is attached hereto as Exhibit B (the bolded words are hyperlinks to the relevant agreements).

6. Once a user has created an account and downloaded the Second Life viewer software, he or she can log into the three-dimensional virtual environment of Second Life. The first time each account is logged into, the user must again agree to the Terms of Service, on a screen that presents the Terms of Service in a scrolling window and requires the user to agree before proceeding. A true and correct copy of this screen is attached hereto as Exhibit C.

7. The second date on each line of Exhibit G is the last date on which the user agreed to the Terms of Service in the scrolling window of the Second Life viewer. That date will be either (a) the date that account was first logged into, or (b) a later date on which the user logged into that account and agreed to a revised version of the Terms of Service. A number of Mr. Evans’ accounts have no such date. This means that, although Mr. Evans created those accounts, he never logged into them. The last date in each row of Exhibit G is the last date the account was logged into. For accounts that were never logged into, Exhibit G reads “N/A.” The same format is used for the accounts listed in Exhibit A hereto. For each Plaintiff, the rows in bold indicate the instances where that Plaintiff has agreed to the current Terms of Service.
