RE: Our Clients: Charles Harris, Dr. Fisher Howard and Unique Product and Services.

Dear Ms. Winfrey,

I write concerning claim resolution.

This firm represents Mr. Charles Harris and Dr. Fisher Howard, authors of the booklet "How America Elects Her Presidents" and Unique Products and Services ("Unique Products"). Mr. Harris is the President of Unique Products. He is also the owner of copyright in "How America Elects Her Presidents" ("Copyrighted Work"). As a copyright owner, he has a number of exclusive rights under the US Copyright Act 1976 (17 U.S.C. §§ 101 et seq). These exclusive rights include the right to reproduce the Work, and to publish and communicate the Work to the public (including by way of sale, broadcast). It is an infringement of copyright to do any of the acts comprised in the copyright in relation to the whole or a substantial part of the Work, or to authorize such an act, without the permission or license of the copyright owner, here Mr. Harris.

It has come to my client's attention that you and your company HARPO through one of your renowned TV shows "Oprah Winfrey Show" has illegally used and plagiarized the exact

contents/questions of "How America Elects Her Presidents" resulting infringement of Mr. Harris' copyright. The purpose of this demand letter is to advise you that copying of the content/questions from "How America Elects Her Presidents" and broadcasting it on T.V without Mr. Harris' permission amounts to violation of US Copyright Act 1976 (17 U.S.C. §§ 101 et seq).

FACTS

The relevant facts of this case are undisputed and liability is clear in this matter. As stated above, my Client Mr. Harris is the author of the booklet "How America Elects Her Presidents". During and prior to 2000, Mr. Harris created and wrote "How America Elects Her Presidents", a non-dramatic literary work authored in United States. Mr. Harris had applied and received a Certificate of Registration for his booklet "How America Elects Her Presidents", dated and identified as follows: January 6, 2000, No. TXu-931-707. Thus, Mr. Harris is the owner of the copyright in the booklet. A true and correct copy of the Certificate of Registration is attached herewith as "**Exhibit 1**". The booklet has also been acknowledged by The Democratic Party (Democratic National Committee) and The Republican Party (Republican National Committee). True and correct copies of the acknowledgements dated 2004 are attached herewith as "**Exhibit 2 and Exhibit 3**" respectively. This suffices the proof of Mr. Harris' copyright in the booklet.

Mr. Harris has been corporately selling "How America Elects Her Presidents" through his company Unique Products and Services.

The cause of action in this matter arose during Senator Obama's campaign for President of the United States of America. You through HARPO were supporting Senator Obama's campaign through your "Oprah Winfrey Show". Considering this as a good business opportunity and to widely publicize the booklet "How America Elects Her Presidents", Unique Products offered HARPO to include booklet in then Senator Obama, now President Obama's campaign for President of the United States.

That, on January 1, 2008, Mr. Harris, on behalf of Unique Products, sent a letter to you and offered to include "How America Elects Her Presidents" in Senator Obama's campaign through your "Oprah Winfrey Show" during entire 2008 Presidential campaign. Mr. Harris in his letter also mentioned that "How America Elects Her Presidents" is also available for any change, additions, or deletions to meet the needs of then Senator Obama's campaign. A true and correct copy of the said letter is attached hereto as "**Exhibit 4**".

Mr. Harris also shipped 10 copies of the proposed booklet for the Presidential campaign to the Oprah Winfrey Show in Chicago. A true and correct copy of the front cover page of the proposed booklet is attached herewith as "**Exhibit 5**". The letter and the proposed 10 copies of booklet were certified and tracked to have been delivered on January 11, 2008 to The Oprah Winfrey Show. A true and correct copy of the certified receipt of the shipment is attached herewith as "**Exhibit 6**".

After, not receiving any communication on your part for almost five weeks, Mr. Harris called your company HARPO, which call was answered by Mr. Carlton who explained that neither the Oprah Winfrey Show nor HARPO accepts any calls or packages at any time and that they did not receive any package from Unique Products ever, whereas the certified receipt of shipment shows acceptance of the package.

Mr. Harris, with no option to know what happened to his proposal and the booklets, wrote another letter to you on February 10, 2010 enquiring the 2008 election proposal relative to the Presidential election bid of Senator Obama. A true and correct copy of the letter is attached hereto as **“Exhibit 7”**. However, there was no response to this letter either.

On February 16, 2009, at 4 P.M. (EST) Mr. Harris was watching Oprah Winfrey show and to his shock and dismay he saw you reading out to the public and your viewers exactly same questions as in the booklet “How America Elects Her Presidents”. You were reading out the questions verbatim as in the booklet “How America Elects Her Presidents” from 4x6 laminated Q cards in your hand. Just to name a few, you asked “A person must live in the U.S. how long before they become President?” **“Exhibit 8 [Page 18: Question 3 of the booklet]”** Who was the heaviest President?” **“Exhibit 9 [Page 24: Question 12 of the booklet]”** “The Only President who never went to school?” **“Exhibit 10 [Page 25: Question 19 of the booklet]”** It is not a coincidence that you asked these questions on your show after Mr. Harris COPYRIGHTED material was mailed to you. You developed one of your daily programs based on the information in the booklet. You were also highly praising the information contained in the booklet.

The questions in the booklet “How America Elects Her Presidents” were developed and designed by and for Unique Products and Services, not your show. You copied questions verbatim from Mr. Harris’ “Copyrighted Work”, without his permission or license. Due to this violation, this copyrighted 2008 version was never mass produced. This amounts to infringement of Mr. Harris’s copyright in the booklet “How America Elects Her Presidents”.

LIABILITY

Mr. Harris has authorized me to bring this matter to your attention, demand and negotiate a favorable monetary resolution to this matter. The purpose of this letter is to seek to negotiate a fair settlement for your profits earned from and for damages that are the result of your illegal use of Mr. Harris’ “Copyrighted Work”.

You and your company HARPO are jointly, severally and vicariously liable under the Copyright Act of 1976, 17 U.S.C. §§ 101 et seq., Tortious Conversion, Quantum Meruit, Unjust Enrichment. In terms of liability, we rate this case as being 100% favorable.

1. Copyright Infringement

Your and HARPO’s acts as stated above constitute copyright infringement in violation of the Copyright Act, 17 U.S.C. §§ 101, et seq.
