ORDER

AND NOW, this 2nd day of *February*, 2015, upon consideration of Defendant AssureRx Health, Inc.¹ (“Defendant”)’s Motion to Dismiss the Second Amended Complaint and Request for Attorney’s Fees (Docket No. 20), Plaintiff Visual Communications, Inc. (“Plaintiff”)’s Response in Opposition (Docket No. 21), Defendant’s Reply Brief (Docket No. 22), and Plaintiff’s Sur-Reply Brief (Docket No. 23), it is hereby **ORDERED** that:

1. Defendant’s Motion to Dismiss Plaintiff’s Second Amended Complaint is **DENIED**;
2. Defendant’s Request for Attorney’s Fees is **DENIED**;
