¹ Since Mr. Talbert has not filed objections, I need only give some reasoned consideration to the report and recommendation. Henderson v. Carlson, 812 F.2d 874, 878 (3d Cir. 1987). Mr. Talbert has clearly failed to exhaust his state court remedies, because he has not yet gone to trial on the pending state charges. The petition is symptomatic of Mr. Talbert's litigious nature rather than any extraordinary circumstance which would warrant habeas jurisdiction in this pre-trial setting. Mr. Talbert has filed seven lawsuits against state authorities during his current incarceration alone. Accordingly, I find that Judge Hart's report and recommendation is well reasoned and free of clear error. *See* Fed. R. Civ. P. 72(b) advisory committee's note.
