AND NOW, this 24<sup>th</sup> day of June, 2016, after considering the petition for a writ of habeas corpus filed by the petitioner (Doc. No. 1), the response to the petition filed by the government (Doc. No. 25), the reply filed by the petitioner (Doc. No. 28), the amended response to the petition filed by the government (Doc. No. 32), and the reply to the amended response filed by the petitioner (Doc. No. 38); and after considering the state-court record; and after considering the report and recommendation filed by United States Magistrate Judge Elizabeth T. Hey (Doc. No. 34); and after considering the objections to the report and recommendation filed by the petitioner (Doc. No. 39); accordingly, it is hereby **ORDERED** as follows:

1. The report and recommendation (Doc. No. 34) is **APPROVED** and **ADOPTED**;
2. The petitioner’s objections (Doc. No. 39) are **OVERRULED**;<sup>1</sup>
3. The petition for a writ of habeas corpus (Doc. No. 1) is **DISMISSED WITHOUT PREJUDICE**;
4. The petitioner’s motion for the appointment of counsel (Doc. No. 29) is **DENIED**;

5. The petitioner's motion for a rule to show cause (Doc. No. 24) is **DENIED AS MOOT**;
6. A certificate of appealability **SHALL NOT** issue; and
7. The clerk of court is **DIRECTED** to mark this matter as **CLOSED**.
